1. Regular Monthly Board Meeting called to order by Chairman Randy Julien at 7 pm.
2. Roll Call/Quorum Call – all present.
3. Affidavit of Posting Notice for Regular Monthly Meeting was completed.
4. Minutes of September 12th, 2017 Regular Board Meeting read by Kimberly. Motion to approve the Regular Meeting minutes as presented made by Ralph, seconded by Phil. All in favor; Motion carried. Minutes of the September 23rd, 2017 Special Board Meeting read by Kimberly. Motion to approve the Special Board Meeting minutes as presented made by Ralph, seconded by Phil. All in favor; Motion carried.
5. Treasurer’s report read by Colleen.
Motion to approve treasurer’s report as presented made by Randy, seconded by Ralph. All in favor; Motion carried.
6. October 10th bills were reviewed by the Board
Motion to approve bills as presented made by Randy seconded by Phil. All in favor; Motion carried.
7. Public Comment: None
8. Old Business:
 - A. Fire Board Report given by Randy. The parking lot was resurfaced and new LED lights were installed.
 - B. Road Report given by Gary & Randy. Gravel on Arndt and Monthei is complete, Scott Construction will give them a finishing pass with their grader. Loader and mower are both fixed. There was a beaver dam impacting E Town Line Road, the dam was cleaned out and someone is going to trap the beavers. JJ’s Brush Cutting mowed 22 hours.
 - C. Directing the Plan Commission on further action on the Action Plan per section 4.6 of the Town of Cleveland Comprehensive Plan was discussed. Motion to not pursue an amendment to the Comprehensive Plan at this time made by Phil, seconded by Ralph. 2 in favor, 1 opposed; Motion carried.
 - D. The driveway at the intersection of Old Stage Road and Scholze road was discussed. The landowners are going to install a culvert under the existing driveway to remedy the situation. No action taken.
9. New Business:
 - A. Ordinance 2017-02 to amend ordinance 2000-1-1 to designate Old Highway 10 as an ATV route from the western town line east to McGower Rd and enact a 10 mile per hour speed limit on this stretch was discussed. Randy will contact the ATV club. Motion to table this item until next month made by Randy, seconded by Phil. All in favor; Motion carried.
 - B. Road responsibilities on Johnson Road was discussed. The Town is responsible for 1.16 miles. No action taken.
 - C. Future mowing and brushing was discussed. We will look further into brushing the ditches this winter. Motion to not do any more mowing this year made by Randy, seconded by Ralph. All in favor; motion carried.
