Discussion on Zone Change Petition #2018-11 as requested by Buffalo Nickel LLC, owner and Jack Akers, Secluded Land Company, applicant on property location in the SW1/4-NE1/4 (4.43 acres), the SE1/4-NW1/4 (25.09 acres), and the NW1/4-SE1/4 (10.57 acres) all in Section 29, T24N, R5W, Town of Cleveland, Jackson County, WI. The request is change 40.09 acres of the Official Zoning Map from the R-3 (Cottage) District and A-2 (Forestry and Limited Agriculture) District to the R-6 (Rural Residential) District to allow for single-family homes. The request is to change 7.43 acres of the Official Zoning Map from the A-1 (Agriculture) District to the R-6 (Rural Residential) District for the existing single-family home.
