Driveway Owner agrees to hold harmless the Town of Cleveland from any and all claims made for injuries or damages by the Owner, Agents, or Employees of the Owner, Assigns or Heirs of the Owner against said Town arising from snow removal and/or salt/sanding of private driveway. There must be sufficient base in driveway to support equipment and all gates must be open. Patrolman retains the right to refuse to plow driveway. The Town reserves the right to plow driveways only after all Town roads have been cleared. This contract terminates after the last spring snowfall of 2018. I/we accept the terms of this contract.
